

## Even in winter, keep rooms ventilated

- Constant mechanical ventilation
- If mechanical ventilation is not installed, open a window slightly
- Keep the room temperature at least 18°C
- Be sure to both ventilate and humidify properly

## When eating out, take the following precautions:

- Meet in small groups and for a short time.
- Have conversations in a low voice and wear a mask as much as possible.
- Do not share chopsticks and cups.
- Sit diagonally across from each other. As much as possible, do not sit in front of or right next to each other.
- ✤ Use <u>a restaurant which complies with</u> <u>guidelines\*</u> such as for proper ventilation.
- (If you feel unwell, do not eat out.)

#### \*Make sure to use **Hiroshima Proactive Guard Establishments** (*Hiroshima Sekkyoku Gādo Ten*).

## Basic infection prevention measures:

- Wear a mask, practice coughing etiquette
- Wash your hands
- Avoid the 3Cs (Crowded places, Close contact settings, Closed spaces)
- Take your temperature every morning
- Refrain from chatting and avoid peakhours when using public transportations
- Keep a record of your daily activities (e.g. People you meet, the time of meeting)

## 5 situations that increase the risk of infection:

- Social gatherings with alcohol
- Long meals in large groups
- Conversations without a mask
- Living together in close quarters
- Moving from place to place

 Self-employed persons' consumption tax and local consumption tax: Wednesday, March 31

There is a ticket system in place to reduce crowding. You will need a ticket to enter the venue. You can get a ticket on the day at the venue or in advance via Line. If the venue is particularly crowded, you may be asked to come another day.

**<u>Note:</u>** Except for Hatsukaichi and Kaita, you cannot file your taxes at the tax office itself.

# 20 or older? You must join the National Pension

20歳になったら国民年金(P6)

Everyone—including students—aged 20 to 59 old who lives in Japan must join the National Pension (*Kokumin Nenkin*).

If you have trouble paying because of financial reasons, there is support available (e.g. delayed payment for students or young people, and partial or total exemption for others)
