# 20 or older? You must join the National Pension

20歳になった。 国民年金(P6)

Everyone—including students—aged 20 to 59 old who live in Japan must join the National Pension (*Kokumin Nenkin*). Please contact the following office if you have not yet received an enrollment notification even though two weeks or more have passed after you turned 20 years old, excluding people enrolled in Employee Pension Insurance (*Kōsei Nenkin*).

If you have trouble paying the insurance premium because of financial reasons, there is support available (e.g. delayed payment for students or young people, and partial or total exemption for others)

# COVID-19 Vaccine Update: Coupons for 3rd dose of the vaccine

新型コロナウイルスワクチン:追加接種(3回目接種)用の接種券が届かない人へ(2022年1月1日号P3)

For residents in the city who have completed their 2<sup>nd</sup> dose of the vaccine over 8 months ago but have not yet received their coupons for their 3<sup>rd</sup> round, as well as those who have misplaced or lost their coupons, please reapply at your local ward office. #### **Required Forms**

- Application form (for 3<sup>rd</sup> round)
- One of the following documents (copy acceptable) that you have been vaccinated for the 1<sup>st</sup> and 2<sup>nd</sup> rounds: Certificate of Vaccination for COVID-19, record of vaccination, copy of your pre-vaccination questionnaire
- Form of I.D. (driver's license, health insurance card, My Number Card, etc.)

#### Examples of individuals who may need to reapply:

- Someone who moved to Hiroshima City after being vaccinated in another city
- Someone who received previous shots abroad (Applies only to individuals who received the Pfizer/ Moderna/ AstraZeneca vaccines.)
- Individuals who received the vaccine at work, but have not filed for the 3<sup>rd</sup> dose yet.

#### **Deadlines**

- Income tax, recovery special income tax, residents tax (municipal and prefectural), and gift tax:
   Tuesday, March 15<sup>th</sup>
- Self-employed persons' consumption tax and local consumption tax:
   Thursday, March 31st

#### Precautions to prevent the spread of COVID-19

It is possible to file taxes online or by mail. Please make use of these methods to prevent the spread of COVID-19. If filing in-person, please take necessary precautions to prevent infection: wear a mask, wash (sanitize) your hands and fingers frequently, check your temperature regularly. People who have a fever of over 37.5 degrees Celsius may be asked to refrain from coming to the filing venue.
