Special Benefit for Households Raising Children (Kosodate-setai Seikatsu Shien Tokubetsu Kyūfukin) Application Deadline: February 28, 2023



子育て世帯生活支援特別給付金の申請はお済みですか ひろしま市民と市政 1月15日号 (P6)

Households with children under the age of 18 (or 19 for those with disabilities) are eligible to receive up to 50,000 yen per child. Applications must be submitted to City Hall **by Tuesday**, **February 28, 2023** in order to receive this benefit. If you are eligible to receive this benefit, but have not completed the application yet, please do so by the due date.

- * If you have already received this benefit, it is not possible to receive it again.
- * Those whose income or those whose spouse's income is above a certain level are not eligible to receive this benefit.

Tax Return Deadlines

Deadlines

• Income tax, recovery special income tax, residents tax (municipal and prefectural), and gift tax:

Wednesday, March 15

Self-employed persons' consumption tax and local consumption tax:

Friday, March 31



Who needs to file tax returns and who is exempt?

The criteria used to determine who needs to file taxes, and who does not, is an extremely personalized process. If you are uncertain, please contact your local tax office to figure out the best course of action for you. A list of tax offices can be found below.

- * If you wish to use either medical expenses or social insurance premiums for income tax deduction purposes, you will need to file a final tax return (*kakutei shinkoku*).
- * If it is difficult for you to pay your taxes due to disasters or any other unavoidable reasons, you may be granted tax collection postponement (*yūyo*) or tax collection reduction/exemption (*genmen*). Please consult with the municipal tax office of your residential area.

Where to get tax forms and what kind of documents are required

The required forms will vary by applicant, so please be sure to check online or at your local tax office for details regarding what sort of forms are needed.

Income tax return form

Forms for income tax are available on the National Tax Agency's website or at taxation offices (zeimusho).

Residents tax return form

Forms for residents tax are available on the Hiroshima City website or at municipal tax/tax rooms.

My Number (12-digit Individual Number) required

When filling final tax returns, applicants will need to provide proof of their Individual Number, also known as My Number. You will need to your hard plastic My Number Card, Notification Card, or other form that has your number written on it. In addition, in some cases, ID (or a copy of ID) which can be used to prove your identity, such as driver's licenses and national health insurance cards, will also be required.

Monly Notification Cards with information, such as name and address, identical to Resident Records (Jūmin Hyō) will be accepted.

Online tax returns using the National Tax Agency's eTax website

File your tax return online via your home computer or smartphone! After completing the form, simply send it through the eTax system (electronic application) to file. Using this online tax return filing system, you can file your taxes anywhere, anytime! Applications are processed 24 hours/day until March 15. You can also print out your completed form and send it in via postal mail. For more information about eTax, please see the National Tax Agency website (Japanese only).



Form submission and consultation

1. Income, gift, and consumption taxes

Please submit your form to your local taxation office.

To confirm which office to should submit your form to, see Hiroshima Tax Bureau website (Japanese only).



Filing venue at NTT Cred Hall

Taxes for Hiroshima (Higashi, Minami, Nishi, Kita), Hatsukaichi, and Kaita can be filed at the following venue on these dates:

Date	February 16 (Thurs)-March 15 (Wed)
Time	Reception: 8:30 am-4 pm Consultation: 9 am-5 pm

To avoid crowding, the venue has a ticket system in place. You will need a ticket to enter the venue. You can get a ticket on the day at the venue or in advance via the LINE app. If the venue is particularly crowded, you may be asked to come another day.

Note: Except for Hatsukaichi and Kaita, you cannot file your taxes at the tax office itself.

Consultation on weekends and holidays

Consultation is not available at any of the venues on weekends and public holidays. However, on February 19 and 26 (Sundays), filing and consultation will be available at NTT Cred Hall only for those under the jurisdiction of Hiroshima Higashi, Minami, Nishi, and Kita Tax Offices.

Public vocational training programs: Hello Training

ハロートレーニング(公的職業訓練)のご利用を ひろしま市民と市政1月1日号 (P3)

Hello Training are public vocational training programs for job seekers who wish to acquire the necessary skills and knowledge in order to get a new job. Training is free, but educational material fees are required.

There are two types of trainings programs:

① **Job Seeker Training Program** (*Kyūshokusha shien kunren*)
For job seekers who are not covered by unemployment insurance (*Koyō hoken*).

2 Public Job Seeker Training Program (Kōkyō shokugyō kunren). For job seekers who are covered by unemployment insurance (Koyō hoken). There are also training programs for people who graduated from school without finding a job.

Support System for Job Seekers (*Kyūshokusha shien seido*)

By taking advantage of this support system, job seekers who satisfy certain requirements can receive vocational training benefits (*Shokugyō kunren jukō kyūfukin*), of 100,000 yen per month while taking vocational training.
