

Important Notice for Households with Children (Excluding Single-Parent Households)

the Special Stipend for Low-Income Households with Children

As a general measure to help with the cost of living, the City of Hiroshima will provide 50,000 yen to low-income households with children under the age of 18 (or 19 for those with disabilities).

★ Those who received the special stipend for fiscal year 2022 (FY 2022) do not need to apply; The City of Hiroshima will deposit the stipend into the bank account where you received the stipend for FY 2022.

**1. Allowance amount**

50,000 yen/child

2. Those who must apply in order to receive the stipend

Those who are raising

- Children born between April 2, 2005 and February 29, 2024
- Children with disabilities born between April 2, 2003 and February 29, 2024

and fall under either Category ① or ② must apply.

Categories:

- ① Individuals who are exempt from paying residents tax for FY 2023
- ② Households whose income has decreased on or after January 1, 2023, due to the rising cost of living (food costs, etc.) and whose income is at the same level or lower than those eligible for exemption from residents tax.

Residents Tax for FY 2023 is a tax paid by those who have a registered Japanese address as of January 1, 2023, and earned income the previous year.

- 👉 **It is not possible to receive multiple payments.** Those who have already received the Stipend for Single-Parent Households, which is payable to those who are raising children under the age of 18 (or 19 years old if disabled) on their own due to divorce or the death of a spouse, are not eligible to receive this stipend.
- 👉 Those whose income, or whose spouse's income, is above a certain level are not eligible to receive this stipend.

You must apply for the stipend by February 29, 2024 (Thurs).

★ If you send it via postal mail, it must be postmarked by the date above.

※ If your child is born in February 2024, you must send it via postal mail by March 15, 2024 (Fri). It **must** be postmarked by this date.

※ If the City of Hiroshima cannot confirm your application by this date due to incomplete or missing documents, you will not be eligible to receive this stipend.
